## Investment Philosophy and Objective

The aim of the Fund is to produce capital growth. The Fund will achieve its aim by utilising a diversified portfolio of transferable securities, collective investment schemes, warrants, cash or near cash, deposits and money market instruments. The Fund will primarily consist of instruments with direct underlying gold exposure and shares in companies worldwide whose core business is involved in the mining, refining, production and marketing of gold. Investment may be undertaken indirectly in other commodities, minerals and precious metals. Subject to the requirements of the Regulations, the portfolio will normally remain fully invested. However, not more than 10% of the value of the Fund shall consist of units and/or shares in collective investment schemes.
